**PURPOSE:** To review the City's investment policies and analyze financial market conditions in order to ensure the City continually yields the best returns on its investments. The Investment Advisory Board shall serve as an advisory body to the City on matters relating to the City's investment policies and shall recommend investments to protect capital, provide adequate liquidity, and maximize yield on all funds invested. The Investment Advisory Board will assist the Director of Finance in monitoring the City's compliance with state, federal and local laws and will recommend changes in the City's investment policies, when appropriate, to meet the City's safety, liquidity and return objectives.

**Note:** Two or more City Commissioners and/or Advisory Board members may be present at this meeting. If any person decides to appeal any decision made with respect to any matter considered at this public meeting or hearing, he/she will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
