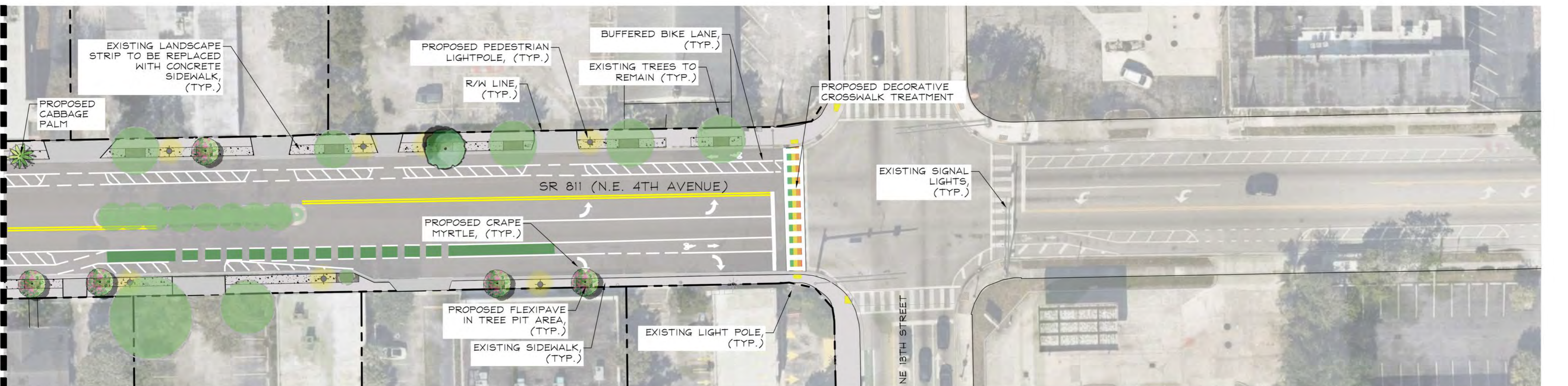
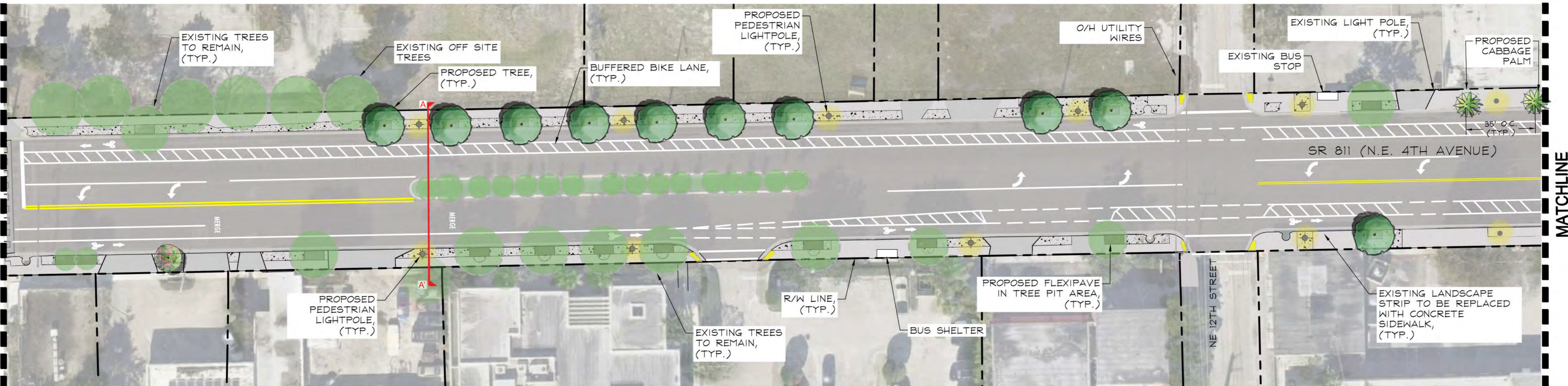
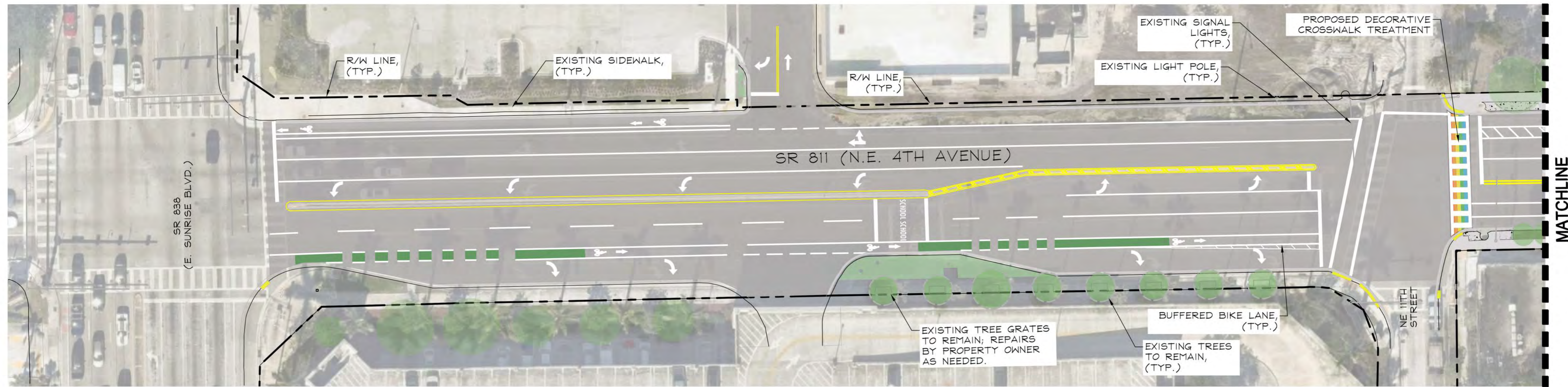

Note: Two or more Fort Lauderdale City Commissioners or Members of a City of Fort Lauderdale Advisory Board may be in attendance at this meeting.

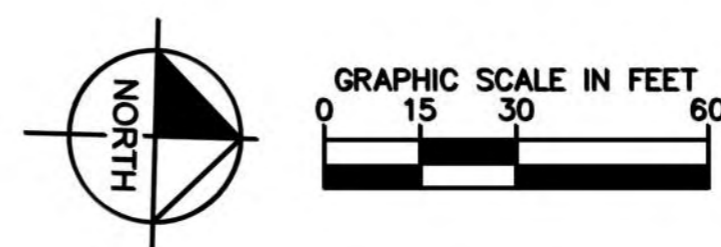

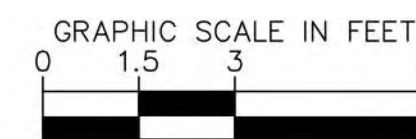
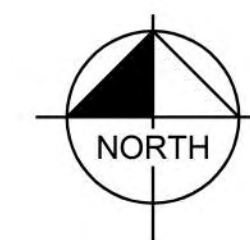
NE 4TH AVENUE - ILLUSTRATIVE CONCEPT PLAN

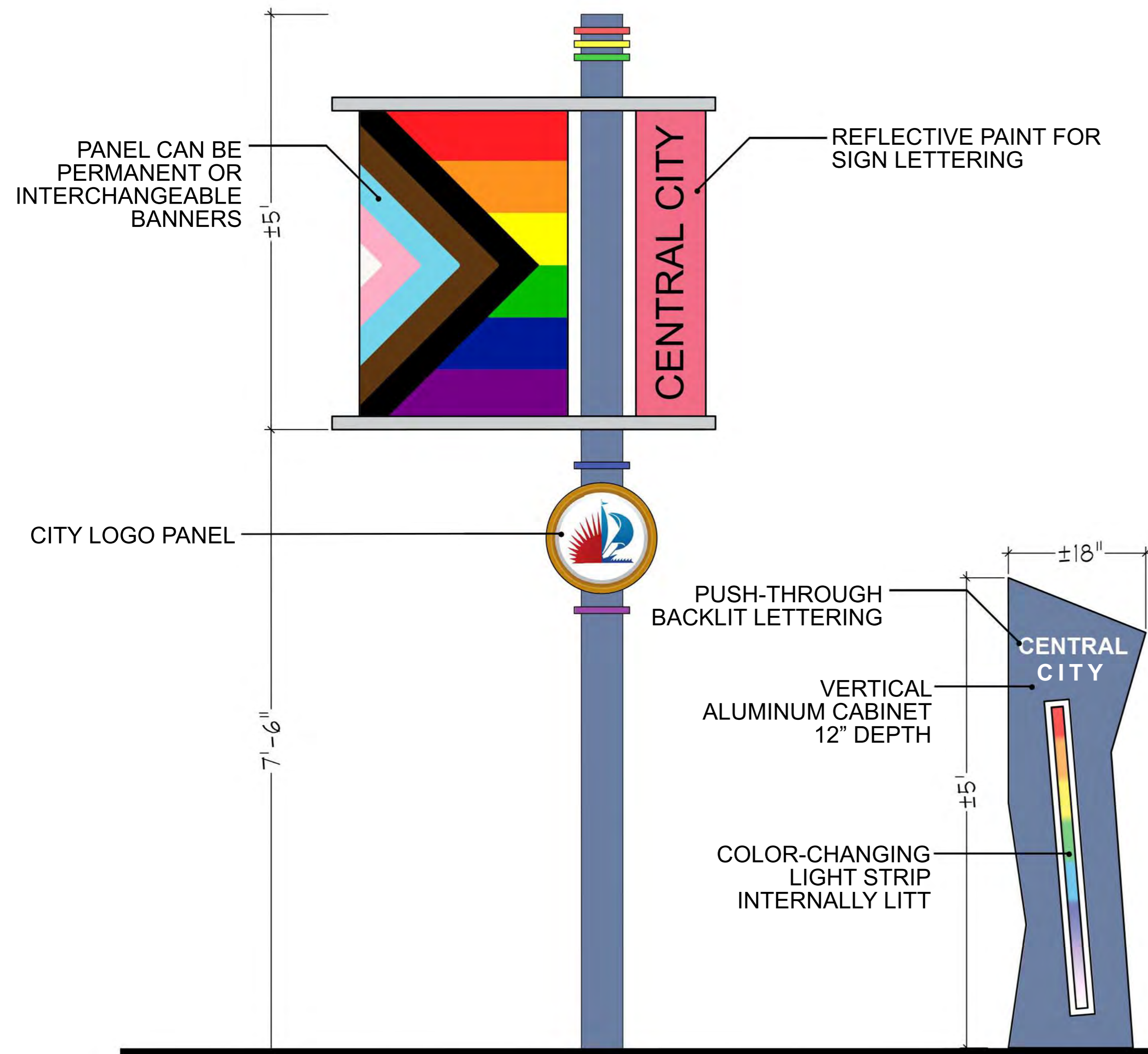

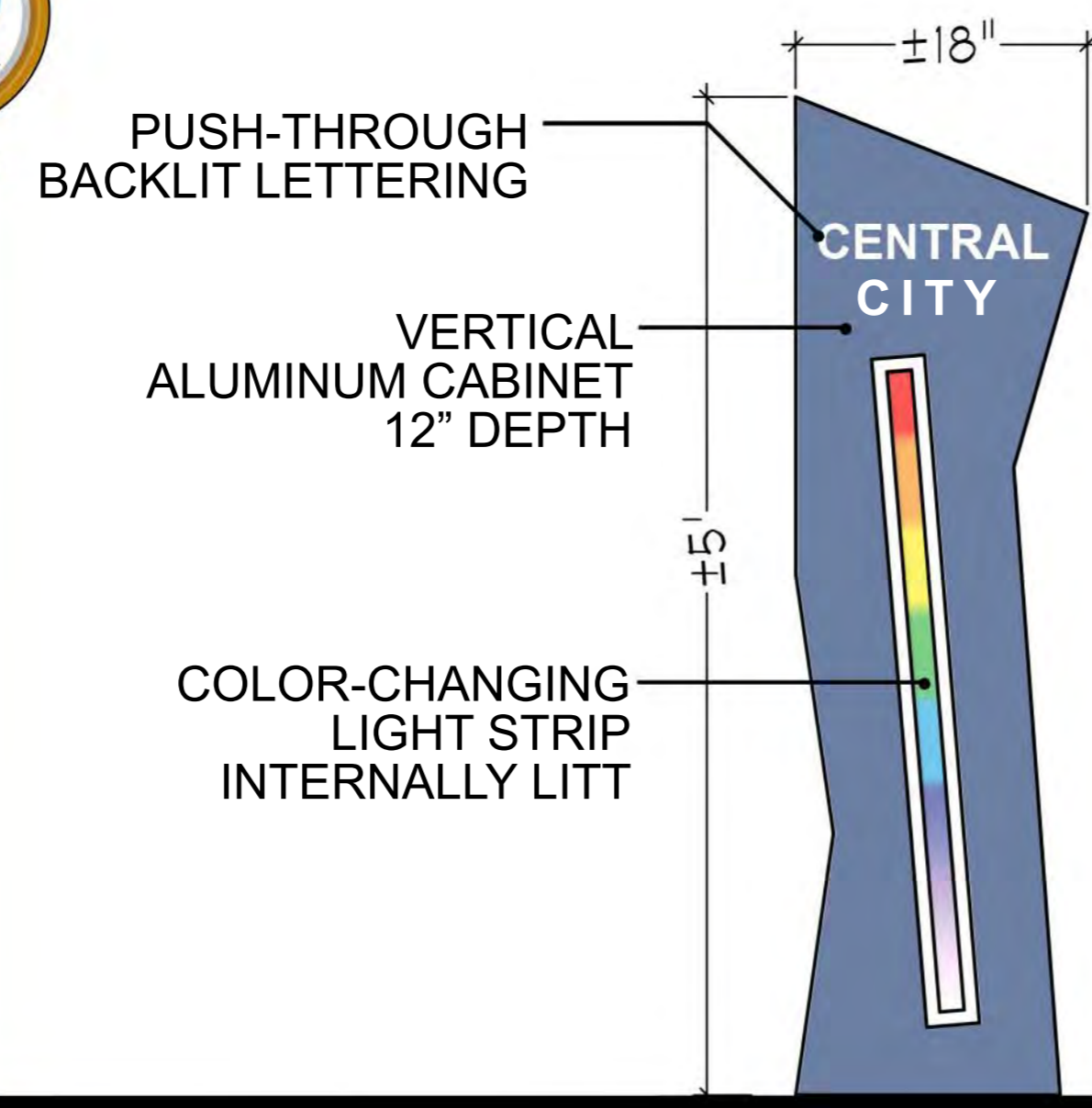

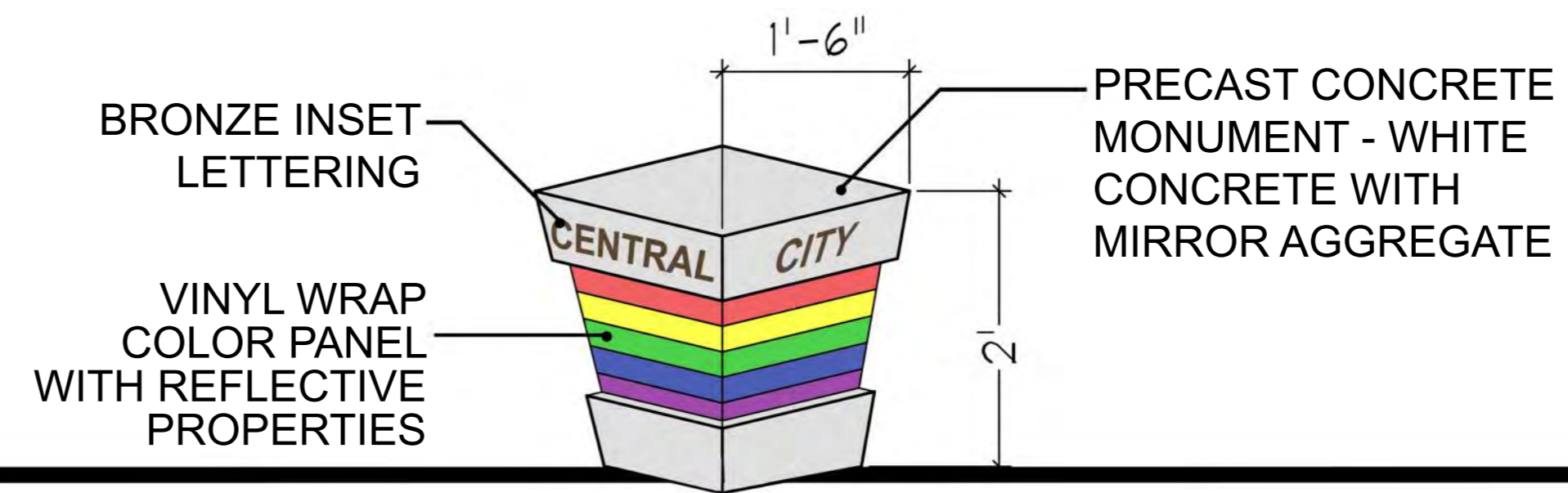
