Technical edits to 8-146.1 are recommended to allow water taxi stops at dedicated right-of-way street ends and other City property. In addition, expansion of staff authority specific to 8-146.1 recommended to include the Marine Facilities Manager. Increase public access via Water Taxi and alternate transportation opportunities are anticipated.
