BEFORE ME, the undersigned authority, personally appeared _____, who upon being duly sworn and cautioned, under oath deposes and says:

1. Affiant is the Applicant in the above cited City of Fort Lauderdale **Business Tax Receipt**.
2. I acknowledge:
 - a. that marijuana is listed on Schedule I of the Comprehensive Drug Abuse Prevention and Control Act of the United States Code Annotated, 21 U.S.C.A. § 801 et seq (the "Act") and that certain actions and conduct involving Schedule I drugs or substances are unlawful under federal law;
 - b. that cannabis and marijuana are defined as all parts of any plant of the genus cannabis, whether growing or not; the seeds thereof; the resin extracted from any part of the plant; and every compound, manufacture, salt, cannabis derivative product, mixture or preparation of the plant or its seeds or resin;
 - c. that the action and conduct involving medical cannabis within the City of Fort Lauderdale is regulated by the City of Fort Lauderdale in Section 47-18.46 of the Unified Land Development Regulations;
 - d. that hemp is defined by 7 U.S.C.A. 1639o(1) as the plant Cannabis sativa L. and any part of that plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis;
 - e. that Section 581.217, Florida Statutes (2020), creates a state hemp program that regulates the cultivation of hemp and the distribution and retail sale of hemp extract;
 - f. that the cultivation, distribution, and retail sale of hemp extract must comply with the requirements of Section 581.217(7), Florida Statutes (2020);
 - g. that the processing and manufacturing of hemp extract must comply with Federal and State regulations and licensing requirements including but not limited to Florida Administrative Code Rule 5K-4.034.
3. The Affiant affirms that the business operating under the above cited Fort Lauderdale Business Tax Receipt shall comply with all requirements of Federal, State, and local laws and regulations.
4. Affiant acknowledges that this Affidavit must be executed and filed with the City's Business Tax Division **five (5)** calendar days prior to obtaining a Business Tax Receipt with the City's Business Tax Division.
5. Affiant is familiar with the nature of an oath or affirmation and is familiar with the laws of perjury in the State of Florida and the penalties therefore.
